

In case you wish to resign from the employment of the College during the period of probation or the College decides to terminate your services, one month prior notice or one month's salary, basic plus AGP and DA, in lieu of the notice period, is required to be given by either party as the case may be. Any request for relieving from service during academic session or semester will not be accepted. However, the management can terminate your service without any notice in case of serious misconduct like willful disobedience and moral turpitude on your part.
