



- Your services may be terminated without any notice and without assigning any reason, in the event, it is observed that your performance is not satisfactory and/or your behavior is not suitable in the interest of the College/Society.
- 6. Your continuous unauthorized absence from duty will be taken seriously and may cause us to terminate your services effective from the date from which you may remain absent from duties.
- 7. You will not be entitled for vacation holiday from the effective date of this appointment and you can avail casual leave to the extent of one leave per completed month on a pro-rata basis.
