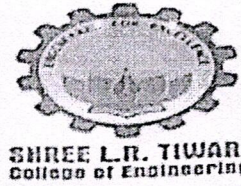
About Shree L.R. Tiwari College of Engineering -

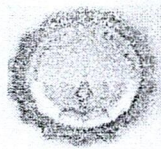
Description:

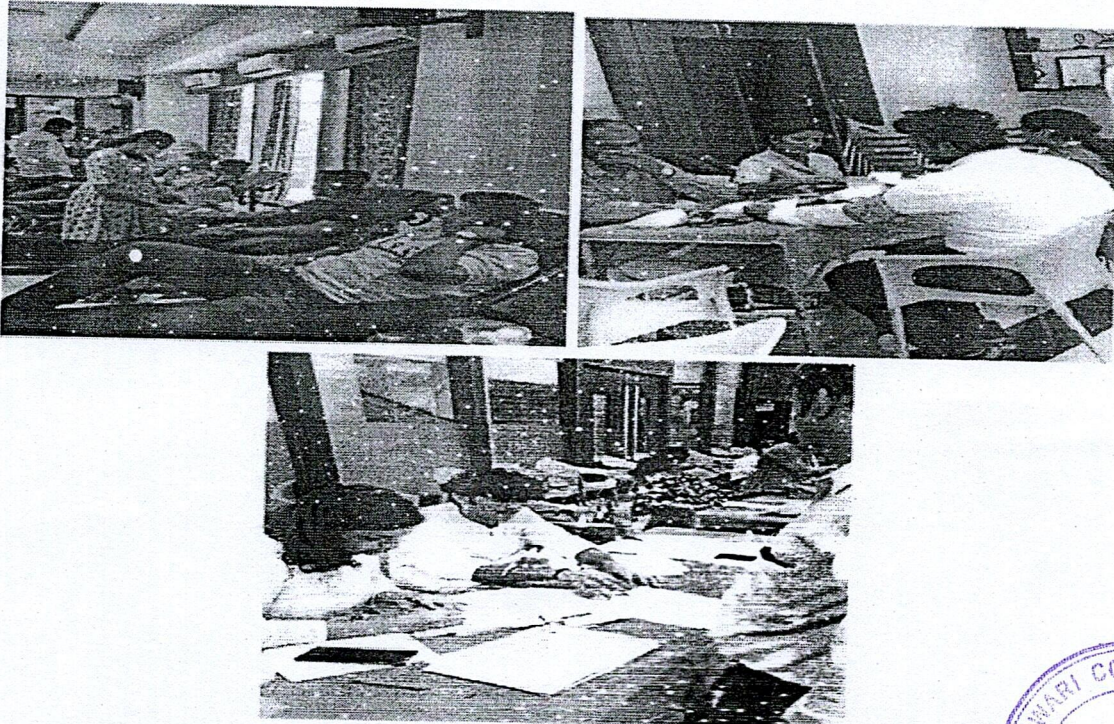
Description:

The NSS unit had organized a Blood Donation Camp, in collaboration with Nair Hospital and Lion Club and Indian development foundation (IDF).

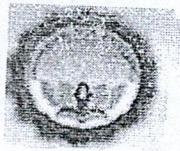
All NSS volunteers gathered at the college campus by 8:15 to arrange the doctor table, beds and nursing table. By 9 am, everything was set for blood donation. Firstly, the weight of the donor was checked, then hemoglobin, then current illness. If the donor has no weakness or illness then he/she was permitted for blood donation. Approx. 350 ml of blood was collected from a particular donor. Blood was donated by college students, staff, People's from outside the college and also NSS volunteers. The camp was supervised by our NSS PO Prof. Menka Singh. After blood donation, the donors were provided with snacks to retain energy. Overall, 103 donors donated the blood with the collection of 36,050 ml of blood of different blood groups.
