(Minority is sanctioned by the state government under the category SC (Scheduled Caste), ST (Scheduled Tribe), VJ/NT (Vimukt Jati and Nomadic Tribe), OBC (other Backward Class) and SBC (Special Backward Class), EBC is sanctioned by central government under the scheme 'Rajashree Chatrapati Shahu Maharaj Shikshan Shulk Shishya Vritti Yojana').

It also shows the Students who are benefited through tuition Fees Waiver Scheme, and other scholarships/Freeships by various Institutional Schemes.

Half of the tuition fees will be reimbursed to the students under the EBC scheme. The Minorities Development Department, Government of Maharashtra is offering the scholarship with a maximum amount of Rs. 50000/- for pursuing professional and technical education for the meritorious candidates belonging to various minority communities.

Dr Panjabrao Deshmukh Vastigruh Nirvah Bhatta Yojna provides hostel fees from Rs. 10,000/- to maximum of Rs. 30,000/-


Government also sanctions a certain amount under Samaj Kalyan fund for students belonging to SC/ST category who are offered with maintenance charges of Rs.150 per month. Remaining students are offered with 50 % of tuition fees.

During covid years as some of the parents were facing problems in paying the fees, Chairman SLRTCE used his authority to give concessions to such students who are from poor financial condition. The decision was taken in the Governing Body meeting after discussion with the Principal and other members Same was conveyed to FRA. 

## **1. Concessions given to the Students: Rs. 45,12,922/-**

**Our Say: Before the Hon'ble Chairman & Committee Members of FRA**

As per the strength of 1542 students of UG courses, the total expected collection is Rs. 13,86,90,000/- whereas we collected Rs. 9,72,75,480/- for Year 2020-21 along with Rs.1,74,97,525/-of previous year dues, which comes to Rs.11,47,73,005/-. We actually given concession in making payment of fees of Rs. 45,12,922/- during the COVID period which is over and above outstanding amount of Rs.3,50,30,311/- . So we pray to the Hon'ble FRA to consider this concession amount given to students.

**Sub: Review Application against fee declared of our College for AY 2022-23.**

Respected Sir,

1. Ours Shree L.R.Tiwari College of Engineering (EN 3423) at Mira Road (East), Dist. Thane, shocked and surprised to know that the Hon'ble Fee Regulating Authority has finalized fee at Rs. 77,000/- for the AY 2022-23 in the meeting held on dated 16<sup>th</sup> November 2022. Our College is a part of MMR Region and being financial capital of Country, it is not possible and consider to have such a low fee compare to several other Colleges in the vicinity affiliated to same University and parting uniform quality of education.
2. Sir, due to substantial reduction in fee from Rs.90,000/- of AY 2021-22 to Rs. 77,000/-, we have decided to file review application against the decision of Hon'ble Fee Regulating Authority and we hope the Hon'ble Authority would reconsider and give us justice as it is matter of survival to us.
3. As such, the Hon'ble Authority has disallowed non-salaries expenditure to the extent of total amounting to Rs. 3,41,23,481/-, the details of which are as follows :
  - (a) The amount of Rs. 45,12,922/- has been disallowed as Scholarship but as such it is concession given to students who are not able to make full payment of fees due to pandemic situation of Covid-19. And we all agreed that during starting of Covid-19 pandemic when everything was on-line at that time and many people are not ready to pay the fees due to severe recession even at Govt. level as well many subsidies have been given to all these people.
  - (b) The amount of Rs. 1,24,66,376/- is disallowed showing as Expenses related to Students (Any other expenses relating to students activity not covered by item 1 to 6). The 90% of these expenses are incurred towards study material supplied to the students annually. If not allowing any single money towards expenses, it means the Authority is not considering basic need of providing journals, papers and teaching materials to the students. The cost of such materials comes to Rs.740/- per semester per subject per student including papers, files and printed teaching learning materials

- (c) The amount of Rs.78,86,410/- is disallowed as Other Expenses – All other Expenses not categories/not grouped in any head. These overall expenses have been incurred towards the basic and reasonable requirement to run the College such as office administrative expenses, security guard and sweeping expenses, Xerox and photocopying expenses website maintenance charges, newspaper, periodicals and magazine expenses, fire safety and first aid expenses, membership and subscriptions, miscellaneous expenses which comes to Rs.78,86,410/- needs to be approved.
- (d) The amount of Rs.83,84,709/- is disallowed showing Excessive repairs and maintenance of building, furniture, equipment etc. In fact, the total amount incurred and claimed at Rs.1,67,69,481/-. This expenses are required to incur due to major repairs and maintenance to the College building also keeping in view that the College is first time going for NBA Accreditation and required to adhere its guidelines and hence such expenses are incurred on the repairs and maintenance on building, equipment, furniture and fixtures. In MMR region, the annual maintenance on residential building is approximately comes to Rs. 36/- to Rs. 48/- per sq. ft. where only one family stays whereas in this College premises around 2000 people including students, faculties and admin staffs are daily attending. Therefore, we should consider around Rs.90/- to Rs.100/- per sq. ft. maintenance cost per annum wherein these includes laboratory, equipment, furniture and its fixtures, etc. However, the Hon'ble Authority is requested to kindly approve the total claimed amount of Rs. 1,67,69,481/- instead of disallowing and deducting 50% of the total expenses.
4. Sir all these above major disallowance amount of Rs. 3,41,23,481/- has resulted into drastic reduction in fee structure from Rs.90,000/- to Rs.77,000/- for AY 2022-23 as against our proposed fee of Rs.98,989/- for AY 2022-23.
  5. Due to declaration of lower fee, financials of the College will be effected very badly and will face lot of difficulties to meet the future obligations and perspective plans of the College.
  6. In view of the above, we hereby sincerely request to kindly look into our Review Application giving us personal hearing and freshly decide our fee structure as proposed for AY 2022-23. For your perusal, we are submitting herewith detailed documentary evidence including receipts/bills of the disallowed expenditure before the Hon'ble Authority.


